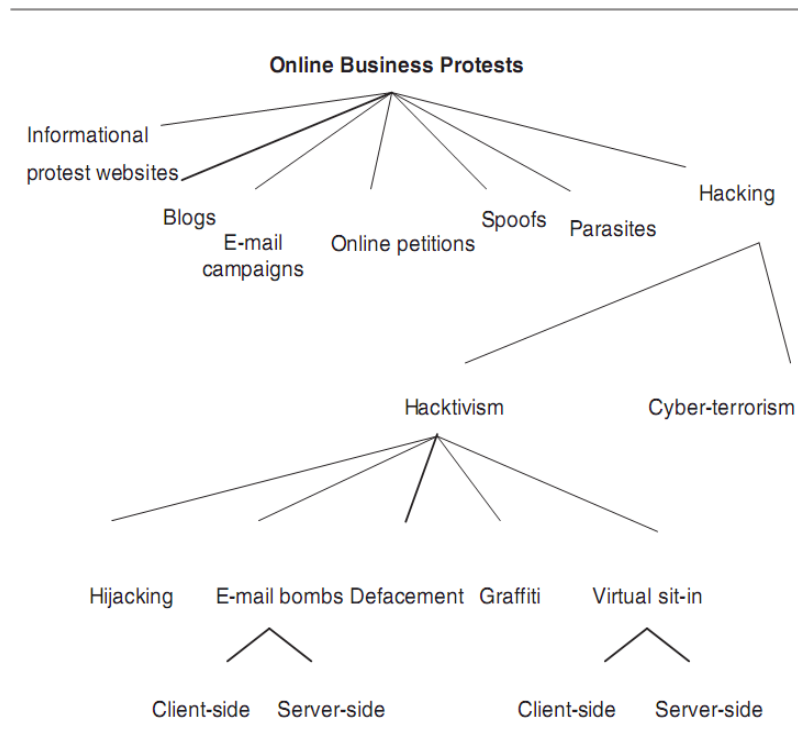


Figure 1 Typology of Online Business Protests
